### About Your TRAINING

All our training modules are now correspondence style with an experienced one-on-one mentor. This means you can train in your own time and without travel and accommodation costs

The Teeth Whitening Associates Distant Learning **Correspondence Training Modules** are approved by the NZCTWA for New Zealand Partitioner Certification

Training for NZCTWA Registered Practitioner Certification is completed in TWO Correspondence Modules

#### 1. THEORY Module

Comprises of your self-study of the NZCTWA THEORY Training Manual followed by the completion of a 30-Question Knowledge Review form

#### 2. PRACTICAL Module

Comprises of your self-study of the PRACTICAL Training Manual followed by watching 5 short explanatory 'how to' videos

Then, during your first couple of whitening's, it's a good idea to record any questions that have arisen. Once this is completed, we schedule a Phone or Zoom call with you to fine-tune anything that has arisen or expand upon anything you are not quite sure of

# About Payment Options

There are **THREE** payment options:

## 1 - Pay in FULL

Once paid in full, we email you both training modules and courier your complete Start-Up package. This provides you with the opportunity to get things set up as you are training

**Or,**

## 2 - By TWO 50% payments.

1. Pay 50% and we begin your THEORY training by emailing you the Theory Training Module
2. Then, after we receive your NZCTWA Theory Knowledge Review Forms back, you pay the remaining 50% and we email the PRACTICAL training Module that consists of a practical manual and links to the 'how-to' training videos. Next working day, we courier your Start-Up package directly to your door

**Or,**

## 3 - By THREE payments.
